Weak Convergence of Partial Sums in Hilbert Spaces With an Application

We prove the weak convergence of normalized partial sums of dependent random functions. The weak convergence is established under the assumption that the variables are Bernoulli shifts which can be approximated with m-dependent variables in Hilbert spaces. The main result is used to provide a test to detect a possible change in the means of random curves.
